Decision details

1. Agreed Outcome

1.1 Worsdell & Vintner, (the Firm), a recognised body, authorised and regulated by the Solicitors Regulation Authority (SRA), agrees to the following outcome to the investigation:

- a. Worsdell & Vintner will pay a financial penalty in the sum of £9,744 under Rule 3.1(b) of the SRA Regulatory and Disciplinary Procedures Rules
- b. to the publication of this agreement, under Rule 9.2 of the SRA Regulatory and Disciplinary Procedure rules; and
- c. Worsdell & Vintner will pay the costs of the investigation of £600, under Rule 10.1 and Schedule 1 of the SRA Regulatory and Disciplinary Rules.

2. Summary of facts



2.1 We carried out an investigation into the firm following a referral by our AML Proactive Supervision team. The firm was originally selected for an on-site inspection by our AML Proactive Supervision team. However, as part of the pre-visit questionnaire (sent to the firm on 30 July 2024) the firm was asked to provide its AML documentation including (but not limited to) its firm-wide risk assessment (FWRA) and policies, controls and procedures (PCPs). The firm was unable to produce such documents and, therefore, the firm was automatically referred to the AML Investigations team, and the inspection did not take place.

2.1 Our investigation identified areas of concern in relation to the firm's compliance with the Money Laundering, Terrorist Financing (Information on the Payer) Regulations 2017 (MLRs 2017), and previously the Money Laundering Regulations 2007 (MLRs 2007), the SRA Principles 2011, the SRA Code of Conduct 2011, the SRA Principles 2019 and the SRA Code of Conduct for Firms 2019.

Firm-wide risk assessment (FWRA)

2.3 The firm did not have in place a documented FWRA between 26 June 2017 and 4 October 2024, in breach of Regulation 18 of the MLRs 2017. The firm is required to have a FWRA which includes the details of the firm's assessment of risk in five key areas. The firm was unable to provide us with any such document as part of the pre-inspection documents

2.4 On 13 September 2024, the AML Proactive Supervision team wrote to the firm highlighting the firm's lack of a FWRA and provided the firm with guidance to produce a compliant FWRA, tailored to the firm's work, clients, and structure.

2.5 On 4 October 2024, the firm sent an email to the AML Associate, with a FWRA attached. Upon review of the document, the firm have clearly taken on board the advice given by the AML Proactive Supervision team and have covered all mandated sections in accordance with Regulation 18(2) of the MLRs 2017. The firm are now operating with a complaint FWRA.

2.6 Consequently, between 25 June 2017 and 4 October 2024, the firm failed to have a compliant FWRA in place in accordance the requirements of Regulation 18(1) and 18(4) of the MLRs 2017.

Policies, controls and procedures (PCPs) / Policies and Procedures (P&Ps)

2.7 Between 26 June 2017 and 4 October 2024, the firm failed to establish and maintain PCPs which mitigate and effectively manage the risks of money laundering and terrorist financing, and regularly review and update them, in breach of Regulation 19 of the MLRs 2017.



2.8 In our letter dated 30 July 2024, the firm was asked to provide its PCPs as part of the 'pre- visit questionnaire'. On 14 August 2024, in an email from Mr Crowther to AML Associate, Gurdeep Bains, it was stated that '; if we had identified a Money Laundering risk, we would not have accepted instructions.' No further documents were attached and therefore the firm was unable to produce any form of documented PCPs.

2.9 On 4 October 2024, the firm sent an email to the AML Associate, with its PCPs. Although the firm have made progress with its PCPs, further guidance will be given to the firm to ensure that the PCPs are fully compliant with Regulation 19 of the MLRs 2017.

2.10 Consequently, it is the case that between 26 June 2017 and 4 October 2024, the firm failed to establish and maintain compliant PCPs to mitigate and effectively manage the risks of money laundering and terrorist financing, pursuant to Regulation 19(1)(a) of the MLRs 2017.

2.11 Prior to this, the firm between 6 October 2011 and 25 June 2017, also failed to establish and maintain compliant appropriate and risksensitive policies and procedures relating to customer due diligence measures and ongoing monitoring, reporting, record-keeping, internal control, risk assessment and management, the monitoring and management of compliance with, and the internal communication of, such policies and procedures, in order to prevent activities related to money laundering and terrorist financing, pursuant to Regulation 20(1) of the MLRs 2007.

Client and matter risk assessments (CMRAs)

2.12 Between 26 June 2017 and 4 October 2024, the firm failed to conduct client and matter risk assessments, pursuant to Regulation 28(12)(a)(ii) and Regulation 23(13) of the MLRs 2017.

2.13 In our letter dated 30 July 2024, the firm was asked to provide its 'template client and matter AML risk assessment'. The firm failed to provide the SRA with any template.

2.14 In a letter dated 2 December 2024, the Investigation Officer asked the firm to provide its current CMRA template, and the date it was implemented, as well as any risk assessment documentation that was previously used when opening new matters.

2.15 On 17 January 2025, the firm produced a template CMRA form, which it stated had been in use since October 2024, as it was attached the firm's PCPs (dated 4 October 2024).

2.16 Therefore, it is the case that between 26 June 2017 and 4 October 2024, the firm failed to conduct client and matter risk assessments, pursuant to Regulation 28(12)(a)(ii) and Regulation 28(13) of the MLRs 2017.



2.17 Prior to this, between 6 October 2011 and 25 June 2017, failed to determine the extent of customer due diligence measures on a risk-sensitive basis, or be able to demonstrate to its supervisory authority that the extent of the measures is appropriate in view of the risks of money laundering and terrorist financing, pursuant to Regulation 7(3) of the MLRs 2007.

3.Admissions

3.1 The firm admits, and the SRA accepts, that by failing to comply with the MLRs 2017:

From 6 October 2011 to 24 November 2019 (when the SRA Handbook 2011 was in force), the firm has breached

- a. Principle 6 of the SRA Principles 2011 which states you must behave in a way that maintains the trust the public places in you and in the provision of legal services.
- b. Principle 8 of the SRA Principles 2011 which states you must run your business or carry out your role in the business effectively and in accordance with proper governance and sound financial risk management principles.

And the firm has failed to achieve:

- a. Outcome 7.2 of the SRA Code of Conduct 2011 which states that you have effective systems and controls in place to achieve and comply with all the Principles, rules and outcomes and other requirements of the Handbook, where applicable.
- b. Outcome 7.5 of the SRA Code of Conduct 2011 which states you comply with legislation applicable to your business, including antimoney laundering and data protection legislation.

And from 25 November 2019 (when the SRA Standards and Regulations came into force) until October 2024, the firm has breached:

- a. Principle 2 of the SRA Principles 2019 which states you act in a way that upholds public trust and confidence in the solicitors' profession and in legal services provided by authorised persons.
- b. Paragraph 2.1(a) of the SRA Code of Conduct for Firms 2019 which states you have effective governance structures, arrangements, systems and controls in place that ensure you comply with all the SRA's regulatory arrangements, as well as with other regulatory and legislative requirements, which apply to you.
- c. Paragraph 3.1 of the SRA Code of Conduct for Firms 2019 which states that you keep up to date with and follow the law and regulation governing the way you work.

4. Why a fine is an appropriate outcome

4.1 The conduct showed a disregard for statutory and regulatory obligations and had the potential to cause harm, by facilitating dubious transactions that could have led to money laundering (and/or terrorist financing). This could have been avoided had the firm established adequate AML documentation and controls.

4.2 It was incumbent on the firm to meet the requirements set out in the MLRs 2007 and MLRs 2017. The firm failed to do so. The public would expect a firm of solicitors to comply with its legal and regulatory obligations to protect against these risks as a bare minimum.

4.3 The SRA considers that a fine is the appropriate outcome because:

- a. The agreed outcome is a proportionate outcome in the public interest because it creates a credible deterrent to others and the issuing of such a sanction signifies the risk to the public, and the legal sector, that arises when solicitors do not comply with antimoney laundering legislation and their professional regulatory rules.
- b. There has been no evidence of harm to consumers or third parties and there is now a low risk of repetition.
- c. The firm has assisted the SRA throughout the investigation and has shown remorse for its actions.
- d. The firm did not financially benefit from the misconduct.

5. Amount of fine

5.1The amount of the fine has been calculated in line with the SRA's published guidance on its approach to setting an appropriate financial penalty (the Guidance).

5.2 Having regard to the Guidance, we and the firm agree that the nature of the misconduct was more serious (score of three). This is because the firm should have been aware of its obligation to have a FWRA and compliant PCPs since June 2017, and further its obligation to have had compliant P&Ps and evidence that all in-scope matters, and appropriate clients were being risk assessed since 2007.

5.3 In addition, a significant proportion of the firm's work falls within scope of the MLRs 2017; therefore, the firm should have been familiar with the obligations imposed by the regulations and should have implemented strict adherence.

5.4 The firm has failed to meet the requirements of the regulations over many years, while carrying a large proportion of work that falls within scope of the regulations. The firm was left vulnerable for a significant period of time and the SRA considers this amounts to a serious breach.

5.5 The impact of the harm or risk of harm is assessed as being medium (score of four). This is because although there is no evidence of any harm being caused, as a result of the firm not having a FWRA, PCPs and a

documented CMRA until October 2024, the nature of its work, in particular its large percentage of in-scope work, suggests the firm had the potential to cause moderate impact by this conduct.

5.6 The 'nature' of the conduct and the 'impact of harm or risk of harm' added together give a score of seven. This places the penalty in band 'C', as directed by the Guidance, which indicates a broad penalty bracket of between 1.6% to 3.2% of the firm's annual domestic turnover

5.7 We recommend a basic penalty at the upper-middle of the bracket. This is because while there were failings identified which formed a pattern of misconduct, and which had the potential to cause significant loss or have significant impact, no evidence of actual harm was identified. The firm should have been aware of its statutory obligations under the MLRs 2007 and MLRs 2017 and the breaches spanned a significant amount of time. Furthermore, the majority of its work falls within scope of the regulations. However, the firm has taken steps to bring itself into compliance and therefore the ongoing risk is now low.

5.8 Based on the evidence the firm has provided of its annual domestic turnover this results in a basic penalty of £10,827.

5.9 We have also considered mitigating factors and consider that the basic penalty should be discounted by ten percent. This is to take account of the following factors as indicated by the Guidance:

- a. The firm took steps to rectify its failures and put in place a FWRA and PCPs and implemented a new and compliant CMRA template. The firm is conducting and documenting risk assessment on files.
- b. Cooperating with the investigation the firm has cooperated with the SRA's AML Proactive and AML Investigation teams.

5.10 The adjusted penalty is therefore £9,744.

5.11 The firm does not appear to have made any financial gain or received any other benefit as a result of its conduct. Therefore, no adjustment is necessary, and the financial penalty is £9,744.

6 Publication

6.1 Rule 9.2 of the SRA Regulatory and Disciplinary Procedure Rules states that any decision under Rule 3.1 or 3.2, including a Financial Penalty, shall be published unless the particular circumstances outweigh the public interest in publication.

6.2 The SRA considers it appropriate that this agreement is published as there are no circumstances that outweigh the public interest in publication, and it is in the interest of transparency in the regulatory and disciplinary process.



7. Acting in a way which is inconsistent with this agreement

7.1 The firm agrees that it will not act in any way which is inconsistent with this agreement, such as by denying responsibility for the conduct referred to above. This may result in a further disciplinary sanction.

7.2 Acting in a way which is inconsistent with this agreement may also constitute a separate breach of Principles 1, 2 and 5 of the SRA Principles.

8. Costs

8.1 The firm agrees to pay the costs of the SRA's investigation in the sum of ± 600 . Such costs are due within 28 days of a statement of costs due being issued by the SRA.
