There is an ongoing criminal and professional investigation, so we are limited into how much detail we can go into, but we have set out the key points about the case before reflecting on some of the issues it raises. This includes the more immediate and longer-term impacts on the compensation fund and consumer protection. We have set out our approach to managing claims linked to Axiom, including that we do not plan at this point to carry out an interim collection of funds.

Also this month, find out about how artificial intelligence might help your firm, alongside risks you will need to consider; we want your views on providing qualifying work experience; and find out about the Legal Ombudsman's views of providing a good service on costs. We continue to deal with the impacts for the public of the collapse of Axiom Ince, which comes on the back of recent increases in the number and size of interventions. We are looking at the issue of compensating clients for financial losses – both over the immediate and longer term. At this point there is not a need for additional in-year contributions to be collected.
