## Decision details

Joseph Mark Glass's practising certificate for 2024/2025 is subject to the following conditions:

1. Mr Glass may not act as a manager or owner of an authorised body.
2. Mr Glass may not act as a compliance officer for legal practice (COLP) or compliance officer for finance and administration (COFA) for any authorised body.
3. Mr Glass does not hold or receive client money, or act as a signatory to any client or office account or have the power to authorise

transfers from any client or office account.

In these conditions the terms are as defined in the SRA Glossary.

### **Reasons/basis**

The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations, and the regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.

### **Decision details**

To intervene into the practice of Joseph Glass, including but not limited to his practice at Abington Law Ltd.

### **Reasons/basis**

Grounds of intervention into the practice of Joseph Glass

- Mr Glass has failed to comply with the SRA Accounts Rules (2019), the Code of Conduct for Solicitors, RELs and RFLs and the Code of Conduct for Firms which are rules made under sections 31 and 32 of



the Solicitors Act 1974 (as amended) (paragraph 1(1)(c) of Schedule 1 of that Act).

- It is necessary to intervene to protect the interests of clients (or former or potential clients) of Mr Glass (paragraph 1(1)(m) of Schedule 1 – Part I to the Solicitors Act 1974 (as amended)).
