2. Mr Ireland may not hold or receive client money, act as a signatory to any client account or have the power to authorise transfers from any client account. In these conditions the terms are as defined in the SRA Glossary.

### **Reasons/basis**

The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations, and the



regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.

## **Outcome details**

This outcome was reached by SRA decision.

### **Reasons/basis**

#### **Outcome of SDT Hearing**

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which reaches its own decision after considering all the evidence, including any evidence put forward by the Respondent. The Tribunal had certified that there was a case to answer.

On 2 December 2024 the SDT considered and approved an Agreed Outcome.

The Tribunal ordered that Mr Ireland be suspended from practice for a period of 1 year from 2 December 2024, such suspension to be suspended for a period of 2 years.

In addition, Mr Ireland is subject to the following conditions on his practice for an indefinite period:

- i. he may not be a COLP or a COFA in an authorised body,
- ii. he may not hold client money subject to the provisions of the undertaking below,
- iii. he will file accountants reports with the SRA as they fall due and will file a cease to hold accountants report when he closes the Firm's client account.

If he is found to have breached any of the conditions above, activation of the suspension of 1 year will follow in addition to any sanction imposed for the breach of conditions.

If the period of 2 years under restriction is successfully completed, the suspended suspension from practice of 1 year will cease to have effect.

Mr Ireland undertakes to close the Firm's client account within 2 months of the date of approval of the Agreed Outcome and to provide evidence of the same to the SRA by 28 February 2025.
